## **ARTICLE IV**

The number of Directors of the Corporation shall be as set forth in the By-Laws. and the number of Directors may be changed from time to time as therein directed, provided that the number of Directors shall never be less than the minimum number required by law.

#### ARTICLE V

At any meeting of Shareholders, a majority of the shares entitled to vote, either in person or through a proxy, shall constitute a quorum.

Shareholders of the Corporation shall have preemptive and preferential rights of subscription to purchase additional shares upon their issue, whether issued pursuant to these Articles or an amendment thereto.

#### ARTICLE VI

The initial By-Laws of the Corporation shall be adopted by the Board of Directors. The power to alter, amend, or revise the By-Laws shall be in the Board of Directors. Such power to amend shall only be exercised at annual meetings or special meetings called for that purpose.
