KNOW ALL MEN BY THESE PRESENTS:

That the undersigned BOISE CASCADE CORPORATION, a corporation organized and existing under the laws of the State of Delaware, and qualified to do business in the State of Idaho, under the provisions of Idaho Code Section 30-1-53, does hereby adopt the following Articles of Incorporation as provided in Idaho Code Section 30-1-54:

Ι

The name of the corporation is BOISE BUILDING SUPPLY, INC.

II

The purpose or purposes for which the corporation is organized is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Code.

III

The period of its duration is perpetual.

IV

The street address of its initial registered office is 300 North 6th Street, c/o C T Corporation System, Boise, Idaho 83702, and the name of its initial registered agent at such address is C T CORPORATION SYSTEM.

V

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) of the par value of one dollar (\$1.00).

The Corporation will not commence business until it has received for the issuance of its shares consideration of the value of one hundred dollars (\$100.00).
