ARTICLES OF INCORPORATION

We, the undersigned, citizens and residents of the State of Idaho, have, and by these presents do, associate ourselves together as a body corporate, and to that end have, and by these presents do, adopt, declare, publish and certify the following Articles of Incorporation:

Ι.

That the name of the corporation shall be: BIGGERS CON-STRUCTION COMPANY, INC.

II.

That the purposes for which this corporation is formed are: A. To carry on and conduct a general construction business including the designing, constructing, enlarging, extending, repairing, completing, remodeling, removing, or otherwise engaging in any work on any class of buildings, industrial plants, power plants, structures, manufacturing plants, and other systems and works of every description, all kinds of excavation, and iron, steel, wood, masonry, mechanical, electrical, and earth construction and insulations, to make, execute, and take or receive any contracts or assignments of contracts therefor or relating thereto or connected therewith; and to manufacture or otherwise acquire and furnish all buildings and other materials and supplies connected therewith or required therefor; to manufacture, produce, adapt, and prepare, deal in and deal with any materials, articles, or things incidental to or required for, or useful in connection with any of its business, and generally to carry on any other business which can be advantageously carried on in conjunction with and

incidental to any of the matters aforesaid for any public or private purpose.

- B. To employ engineers, architects, builders, and contractors for the purpose of or in connection with the construction, erecting, altering, repairing, improving, or doing any other work in conjunction with any buildings or structures of whatever nature in conjunction with the general construction business.
- C. To engage in the business of construction and rigging requiring the use of heavy mechanical equipment, including cranes and rigging devices. To enter into and perform contracts for the grading and/or paving of streets, driveways, sidewalks, courts, alleys and similar areas, deed to manufacture, buy, sell, export, import, act as manufacturers and other agents, and to generally deal in construction machinery of all classes and descriptions, and to enter into contracts or agreements relating to sales campaigns and marketing, and to the design, manufacture, operation, and use of tools and tooling of every kind, character, and description, including, without being limited to, mechanical, pneumatic, hydraulic, electrical, or artistic devices, articles, or designes with any and all persons, firms, corporations, or other legal entity whether domestic or foreign, and to engage in general machinery manufacturing business.
- D. To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, occupy, and manage buildings of every kind and character whatever; to finance the purchase, improvement, development, and construction of land and buildings belonging to or to be acquired by this company, or any other person, firm, or corporation.
- E. To act as consulting engineers, advisors, or counselors for others, and generally assist in the design, construction or sale of buildings of every class or products, and to render servi-

ces for others as engineers, sales engineers, or otherwise in the conduct of their businesses.

- F. To receive, acquire, hold, purchase, dispose of, or convey, mortgage, and/or lease real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and ventures, and other evidences of indebtedness of this corporation or other corporations domestic or foreign.
- G. To conduct business in this state, other states, District of Columbia, territories and colonies of the United States, and in foreign countries, and to have one or more offices and places of business in this state or out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.
- H. To do all acts permitted by the General Business Corporation Act of the State of Idaho, and all other acts that are necessary and expedient to accomplish this corporation's stated purposes.
- I. In addition to all of the acts in paragraph "H" above, to possess all powers, rights and privileges necessary or incidental to the objects or purposes for which this corporation is formed, and to the activities in which it is engaged, or which would further the accomplishment of such objects, purposes or activities.

The term of existence of this corporation is perpetual.

ΙV.

The location and Post Office address of the registered office of this corporation in the State of Idaho shall be the City of Idaho Falls, County of Bonneville, State of Idaho.

The amount of the capital stock of this corporation shall be ONE HUNDRED THOUSAND AND NO/100 DOLLARS (\$100,000.00), divided into one thousand shares of the par value of \$100.00 per share, to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time determine.

The transfer of the capital stock in this corporation shall be restricted in accordance with a provision appearing on the certificates of capital stock, reading as follows:

No transfer of this certificate or the stock represented thereby shall be valid until thirty days after the corporation, through its secretary shall have written notice of the purposes of sale, the number of shares proposed to be sold, and the name of the prospective buyer; and during said days, the corporation shall have the option to buy at the book value at the close of the last fiscal year, any shares of outstanding stock so proposed to be transferred.
