ARTICLES OF INCORPORATION OF WILLIAMS FEED, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, W. E. WILLIAMS, ANNE K. WILLIAMS, D. H. WILLIAMS and GEORGIA WILLIAMS, all citizens of the United States of America and residents of the State of Montana, desiring to form a corporation for the purposes hereinafter set forth, do hereby associate ourselves together for the purpose of forming and establishing a body corporate, and to that end we certify and state as follows:

I

The name of this corporation shall be: WILLIAMS FEED, INC.

IIe

The objects and purposes for which this corporation is formed are:

- 1. To manufacture and sell grain, hay, and other foods for livestock and poultry, and all types of ranch, farm, and garden supplies and equipment.
- 2. To conduct and carry on the business of buying, selling and dealing in all kinds of grain, hay, or other farm produce and farm products, livestock and provisions, fertilizers, and all other kinds of goods, wares, and merchandise, and to do a general commission and brokerage business in any or all of the foregoing kinds of property.
- 3. To transact any mercantile, ranching, farming, commercial, industrial or manufacturing business authorized by Section 15-104 of the Revised Codes of Montana, 1947.
- 4. To own, construct, maintain, rent, and lease properties, real and personal, of every kind and description.
- 5. To own, deal in, mortgage, pledge, or otherwise encumber and to sell, exchange, and otherwise transfer real and personal properties of every nature whatsoever.

6. To purchase or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer, or otherwise dispose of shares of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by, any other corporation or corporations wherever organized, with all the rights, powers and privileges of ownership thereof; provided, however, that it is not intended hereby to give the right to exercise any of the powers or purposes in this subdivision mentioned in any case where it is forbidden so to do by any provision of the Constitution or Statutes of the United States of America or the State of Montana.

III.

The principal place of business of Williams Feed, Inc. shall be Beaverhead County, Montana, the post office address of which is Dillon, Montana.

IV.

The term of existence of this corporation shall be forty (40) years from and after the issuance of the certificate of incorporation by the Secretary of State of the State of Montana.
