ARTICLES OF AMENDMENT OF  
ARTICLES OF INCORPORATION OF

Articles of amendment of the articles of incorporation of The Washington Water Power Company are herein executed by said corporation pursuant to the provisions of Revised Code of Washington 23A.16.040 and 23A.16.050, as follows:

1. The name of the corporation is The Washington Water Power Company.
2. The Amendment to the Articles of Incorporation of said corporation is as follows:

The Articles of Incorporation and Restated Articles of Incorporation of the company are amended by deleting therefrom Article First thereof, which reads as follows:

"FIRST, that the name of said corporation is 'The Washington Water Power Co.'"

and substituting therefor the following:

"FIRST, that the name of said corporation is 'The Washington Water Power Company'."

3. The date of the adoption of said amendment by the shareholders of said corporation is May 14, 1971.

4. The number of shares outstanding of said corporation is 6,234,252 shares. The number of shares entitled to vote on said amendment was 6,234,252.

5. The number of shares voted for and against said amendment, respectively, were as follows:

For amendment, 5,412,716 shares

Against amendment, 8,460 shares
