ARTICLES OF INCORPORATION

OF

CONNER'S CAFE, INC.

The undersigned, for the purpose of forming a cc ation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE 1

NAME

The name of the corporation is Conner's Cafe, Inc.

ARTICLE 2

PERIOD OF DURATION

The corporation is to exist perpetually.

ARTICLE 3

PURPOSES OF THE CORPORATION

The corporation shall engage in and transact any and all lawful business as authorized by the Idaho Business Corporation Act.

ARTICLE 4

CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue shall be five hundred thousand (500,000) shares of common stock, having a par value of One Dollar (\$1.00) per share.

ARTICLE 5
