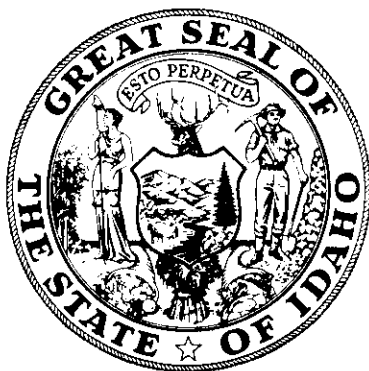

5 The undersigned, for the purpose of forming a corporation
6 pursuant to the provisions of the Idaho Business Corporation
7 Act, adopt the following Articles of Incorporation:

8 ARTICLE 1

9 NAME

10 The name of the corporation is Conner's Cafe, Inc.

11 ARTICLE 2

12 PERIOD OF DURATION

13 The corporation is to exist perpetually.

14 ARTICLE 3

15 PURPOSES OF THE CORPORATION

16 The corporation shall engage in and transact any and

20 CAPITAL STOCK

21 The aggregate number of shares which the corporation
