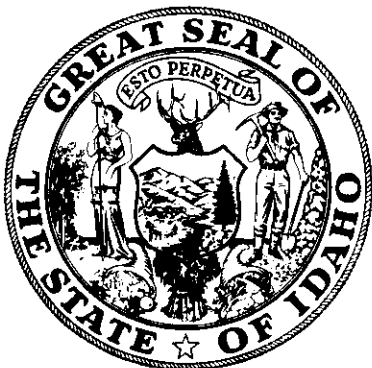

ARTICLES OF INCORPORATION

OF

WESTERN STATES INSULATION COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, being citizens, of the United States of America, and being over twenty-one years of age, having this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, do to that end hereby adopt Articles of Incorporation as follows:

ARTICLE I.

The name of said corporation shall be Western States Insulation Company.

ARTICLE II.

The duration of said corporation shall be perpetual.

ARTICLE III.

The purposes of the corporation are as follows:

1. To operate an insulation business.
2. The undersigned hereby adopt the provisions of Section 30-1-4 of the Idaho Code.

ARTICLE IV.

The capital stock of said corporation shall consist of 2000 shares of common stock with a par value of \$50.00 per share, the total capitalization of said corporation being \$100,000.00

ARTICLE V.

The location and post office address of the registered office of said corporation is P. O. Box 86, 481 S. 3rd E. Soda Springs, Idaho 83276, and Jon C. Hall shall be the registered agent for said corporation.

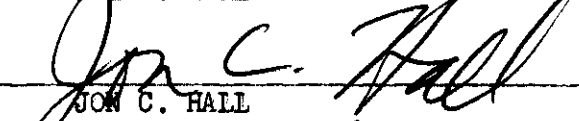
ARTICLE VII.

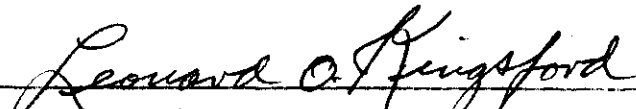
