ARTICLES OF INCORPORATION
OF

DIPPEL LATERAL DITCH COMPANY, LIMITED

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is DIPPEL LATERAL DITCH COMPANY, LIMITED.

SECOND: The corporation is a non-profit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: That the purposes for which this corporation is formed are to won, operate and maintain a certain lateral of the Corbett Slough Ditch Company's Canal, beginning at or near the north line of Section Thirty-six (36) in Township Two (2) South, of Range Thirty-five (35) East of the Boise Meridian, and running thence in a southwesterly direction to the east line of Section Four (4) in Township Three (3) South, of Range Thirty-five (35) East, and to conduct water therein from the Corbett Slough Ditch Company's Canal to the lands of the stockholders for irrigation, domestic and manufacturing purposes and to exercise and possess any other rights, powers, and privileges granted by the laws of this state to corporations organized under the aforesaid act, except such as are inconsistent with the express provisions of these articles.

FIFTH: The address of the initial registered office of the corporation is c/o David Earl Tanner, 295 Tana Drive, Blackfoot, Idaho 83221, and the name of its initial registered agent at such address is DAVID EARL TANNER.

SIXTH: Voting shall be based upon one (1) vote per share basis.

SEVENTH: The aggregate number of shares which the corporation shall have authority to issue shall be 1000, without par value.

TENTH: The board of directors are authorized to levy assessments upon all holders of share of capital stock of this corporation in proportion to the number of shares held, which assessments shall be enforceable by action or by forfeiture, or both, upon notice given in writing twenty days before commencement of such action or such forfeiture. Assessments shall be secured by a lien upon real property to which the ditch rights are appurtenant.
