ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States, all of whom are of full legal age, desiring to form a corporation under the laws of the State of Washington, do hereby adopt and certify the following Articles of Incorporation in triplicate.

ARTICLE I.

The name of this corporation shall be "SPACE METALLIONICS, INC."

ARTICLE 11.

The purposes for which said corporation is formed are as follows:

- To engage generally in the recovering, processing, smelting, refining, treating, buying, selling, and dis-tributing of minerals, chemicals, and other valuable commercial substances or products;
- 2. To engage in research and development of chemical and physical processes for the recovering, processing, smelting, refining and treating of minerals, chemicals and other substances, and to construct and maintain plants and equipment for any such purpose;
- To acquire, purchase, hold, manage, sell, lease and dispose of personal property and real estate of every kind and description;
- 4. To borrow money and to secure the payment of the same by mortgage, contract or pledge upon the whole or any part of the assets of the corporation;
- 5. To acquire, own, hold and vote stock in other corporations;
- 6. To do or perform any other act or thing or carry on any other business incidental or convenient in carrying on the business set forth in any of the pre-ceding paragraphs;
- 7. To qualify and carry on business as a corporation in any other state or foreign country.

ARTICLE III.

This corporation shall have perpetual existence from the date it qualifies.

ARTICLE IV.

The location and post office address of the registered office of this corporation shall be North 130 Stone Street, Spokane, Washington.

ARTICLE V.

The total authorized capital of this corporation shall be \$130,000.00 composed of 1,300 shares of one class of common stock of the par value of \$100.00 per share.

ARTICLE VI.

The total amount of paid-in capital with which said corporation shall begin business is \$600.00.
