ARTICLES OF INCORPORATION OF THE IDAWA GOLD MINING COMPANY

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned have this day associated ourselves together for the purpose of incorporating, under the provisions of Chapter 12, Civil Code Compiled Laws of 1913 and amendments thereto.

I.

The name of said corporation is Idawa Gold Mining Com-

II.

The objects for which this corporation is formed are:

- (a). To search for, prospect, acquire, own, enter, lease, bond, develop, and operate mines and mineral lands of every kind nature and description.
- (b). To acquire, own, enter, or lease mill sites, tunnel sites and tunnel rights, water rights, and terminal facilities, rights of way for canals, ditches, tramways, roads, railroads, pole lines for telephone, telegraph and transmission of electrical energy for illuminating, heating, power and other purposes.
- (c). To erect, own, lease, rent and operate milling plants, reduction works, power and light plants, and other structures necessary for the e proper development and operation of such mines and mineral lands and the working and handling of ores, including such other machinery, roads, railr oads, tramways, ditches, flumes, and such other property as shall be fit and necessary in carrying out the objects in these articles set forth.
- (d). To buy, sell, mill and produce, treat and otherwise handle ores and minerals of all kinds, and to buy, sell, manufacture and deal in mills, machinery, implements, conveniences,

provisions and things capable of being used in connection with mining operations or required by workmen and others employed by the company, including hotels, dwellings and other houses, buildings, structures, conveniences and establishments which may seem directly or indirectly conducive to any of the objects of the company, and to contribute to, subsidize, or otherwise aid or take part in any such operation.

- (e). To acquire, hold and own such real and personal property as may be necessary, or by the board of directors deemed necessary, to properly develop and operate such mines and mineral lands and such property or plants in anyway acquired by the company.
- (f). To sell hypothecate, mortgage and lease any and all property which said company may acquire, and generally to purchase, take on lease or in exchange, hire or otherwise acquire any real and personal property and any rights or privileges which the company may think necessary or convenient for the purpose of its business.
- (g). To enter into, make, perform and carry out/every sort and kind with any person, firm, association or corporation, either private, public or municipal.
- (h). The corporation may donate any and all of its surplus earnings or accumulated profits to the purchase or acquisition of its own capital stock from time to time as its board of directors shall determine, or in any other manner acquire its own capital stock after the same has been issued, and such capital stock so purchased or otherwise acquired may, if the directors so determine, be deposited in the treasury of the company as treasury stock to be thereafter sold or disposed of on such terms and for such prices as the board of directors may from time to time de-

termine, for the purpose of procuring capital for the company.

(i). To do all and every thing necessary, suitable, convenient or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated or incidental to the powers herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation, and this to the same extent and as fully as natural persons might or could do.

III.

The principal place of business shall be in the City of Bismarck, County of Burleigh and State of North Dakota; but the corporation may have a business office without the State at some place within the United States of America, and may hold any meetings of the stockholders, or directors, of the corporation at such office as provided by the By Laws of the corporation.

IV.

The postoffice address of this corporation shall be at Bismarck, Burleigh County, North Dakota.

٧.

The term of its existence shall be twenty years from and after the date of its incorporation.

VI.

The number of its directors shall be six and the names and residences of those who shall be directors, and served as such officers until the election and qualification of their successors are:
