ARTICLES OF INCORPORATION

OF

ABBEEY CORP.

KNOWN ALL MEN BY THESE PRESENTS, That we, the undersigned citizens of the United States of America, each over the age of twenty-one years, do hereby voluntarily associate ourselves together for the purpose of forming a domestic corporation under and by virtue of the laws of the State of Idaho, and we do hereby make, sign, acknowledge and file these Articles of Incorporation as follows:

ARTICLE I.

The name of this corporation is and shall be:- Abbee Corp.

ARTICLE II.

The objects and purposes for which this corporation is formed are as principals, agents or otherwise, to do in any part of the world any and every of the things herein set forth or permitted by law to the same extent as natural persons might and could do. In furtherance and not in limitation of the general powers conferred by the laws of the State of Idaho, we do expressly provide that the corporation shall have power:

(a) To buy, sell, rent, build, lease and trade in buildings and structures, of all kinds, and also in land upon which the same may be located, adjacent or near, or other land or premises.

(b) To purchase, rent or acquire, furniture, furnishings, appliances, draperies and personal property of every kind and to sell or dispose of the same. Including communication media; radio and television equipment and machinery for the operation thereof.

(c) To hold, lease, mortgage, hypothecate and acquire by operation of law, or otherwise, any interest, claim or title in any real or personal property of any kind and wherever situated.

(d) To enter into and carry out contracts and agreements of any kind or amount with any person, firm, association, corporation, the Federal, or Foreign or State governments or any political subdivision, corporation or agency of any of them.

(e) To borrow and lend money and make and take notes, mortgages, bonds, deeds of trust or other evidences of indebtedness in connection therewith; and to open, maintain and operate bank accounts and credit arrangements with any bank, loan company or commercial or financial institution, anywhere.

(f) To commence, prosecute, defend or settle any and all law suits or legal actions in any Court or before any Board, Commission, Referee or other authorized body or person.

(g) To own, hold, lease, transfer and conduct any kind of property, merchandise or business necessary or advantageous to this corporation in carrying on its business activity.

(h) To do and perform every act and thing necessary to carry out the above-enumerated purposes, or calculated, directly or indirectly, to the advancement of the interests of the corporation, or to the enhancement of the value of its stock, holdings, good-will, reputation, or property.

### ARTICLE III.

The corporate existence of this corporation shall be perpetual.

### ARTICLE IV.

That the place where the principal business of this corporation shall be transacted is 836 LaCassia Drive, Boise, Idaho, and the location of postoffice address of the corporation's registered office in this State shall be 836 LaCassia Drive, Boise, Idaho.

### ARTICLE V.

The authorized capital stock of this corporation shall be Fifty Thousand (50,000) shares of common stock of the par value of one (\$1.00) dollar. All stock shall be fully paid and non-assessable.

ARTICLE VI.


That the corporate powers of this corporation shall be vested in a Board of Directors which shall consist of not less than three nor more than eleven directors, as provided by the By-Laws, to be elected as provided by the By-Laws.

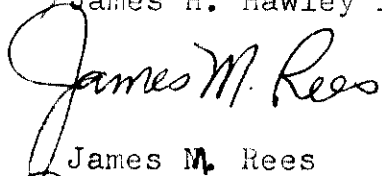

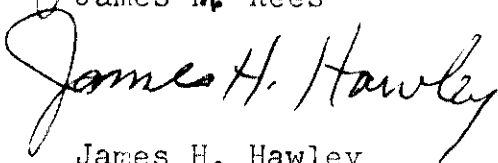
