ARTICLES OF INCORPORATION

LEWISTON FLYING CLUB, INC.

An Idaho Corporation.

The Undersigned, acting as incorporators of a corporation under the Idaho Business Corporations Act, adopt the following Articles of Incorporation for such Corporation.

FIRST: The Name of the Corporation is LEWISTON FLYING CLUB, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

To conduct, for a profit, and to engage in and conduct general flying business, including the repairing of aircraft, the carrying for hire of passengers and freight, both on special trips and as common carriers on regularly established routes, to crop dust, and to carry on the general business of buying, selling, repairing, testing and flying airplanes and flying machines of every description; teach and instruct student pilots; To rent, lease and sell aircraft; To repair, remodel and otherwise improve aircraft To generally deal in airplanes, all kinds; flying machines, helicopters and aircraft of any and all types whatsoever; To deal in parts and supplies for aircraft; To maintain a service station for the repair, overhauling, general maintenance and testing of aircraft. said business anywhere in the United States of America, and particularly in the State of Idaho.

To have one or more offices and places of business in and out of the State of Idaho, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and convey real and personal property both in and outside of the State of Idaho.

To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers herein set forth, either alone or in association with other corporation, firms or individuals, and to do every act or thing incidental or appurtenant to or growing out of or connected with the aforesaid objects and purposes, or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized, and to use and apply surplus earnings or cumulative profits to the purchase or acquisition of its own capital stock from time to time and to such extent and in such manner and upon such terms as its Board of Directors shall determine.

To enter into contracts or obligation of any kind or type essential, necessary or proper to the transaction and conduct of its ordinary affairs for the purposes of the corporation; To contract and hire labor necessary or convenient to the conducting and operation of said business, and to do any and all things regularly, necessarily, properly or incidentally done in the conduct of said business, and to have all the power to generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform, connected with the general overall objects and purposes for which this corporation is formed.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is TWO THOUSAND, all of which shall be common stock having a par value of ONE HUNDRED DOLLARS each.

FIFTH: The address of the initial registered office of the corporation is 3427 4th Street, Lewiston, Idaho 83501.

SIXTH: The name of the initial registered agent of said corporation at its registered office is HAL HEDRICK.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify are;
