The undersigned, MARTIN CRABB and FRANK H. SMITH, the presid-  
ing officer and secretary, respectively, of the regular meeting of  
The Presbytery of Twin Falls held September 14, 1949, hereby cer-  
tify:

That The Presbytery of Twin Falls is a religious corporation  
organized and existing under and in accordance with the provisions  
of Chapter 11, Title 30, Idaho Code.

That in accordance with the provisions of Section 30-1103,  
Idaho Code, at a regular meeting of The Presbytery of Twin Falls,  
held on the 14th day of September, 1949, at the Presbyterian Church  
in Twin Falls, Twin Falls County, Idaho, at which meeting a quorum  
of members was present, the corporate name of The Presbytery of  
Twin Falls was changed to Presbytery of Southern Idaho by the unani-  
mous vote of the meeting.

That notice of the time and place of holding said regular  
meeting for the purpose of changing the corporate name of said  
corporation was given by publication of a notice to that effect  
once a week for four consecutive weeks, to-wit: August 24, 30;  
September 6, 13, 1949, in the Twin Falls Times-News, a newspaper  
published in Twin Falls, Twin Falls County, Idaho, in which County  
the said meeting was held. That said notice designated the regular  
meeting at which it was intended to vote on the proposition of  
amending the articles of incorporation and stated that the propos-  
ed manner of amending the articles of incorporation of said cor-  
poration was by changing the name of said corporation to Presbytery  
of Southern Idaho.

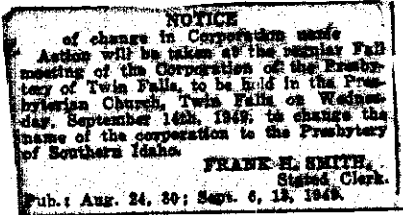
