That in accordance with the provisions of Section 30-1103, Idaho Code, at a regular meeting of The Presbytery of Twin Falls, held on the 14th day of September, 1949, at the Presbyterian Church in Twin Falls, Twin Falls County, Idaho, at which meeting a quorum of members was present, the corporate name of The Presbytery of Twin Falls was changed to Presbytery of Southern Idaho by the unanimous vote of the meeting.

That notice of the time and place of holding said regular meeting for the purpose of changing the corporate name of said corporation was given by publication of a notice to that effect once a week for four consecutive weeks, to-wit: August 24, 30; September 6, 13, 1949, in the Twin Falls Times-News, a newspaper published in Twin Falls, Twin Falls County, Idaho, in which County the said meeting was held.
