JUSTICE FOR INDIA NETWORK, INC.

(Adopted by a unanimous 5-0 vote of the Board of Directors on the 7th day of February, 2014)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Idaho, do hereby certify the foregoing:

**ARTICLE I
NAME AND PRINCIPAL OFFICE LOCATION**

Section 1. Name. The name of the Organization shall be the Justice for India Network, Inc. ("JIN"), a not-for-profit, non-member, non-stock Organization incorporated under the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code, in the State of Idaho, with a principal place of business in Boise, Idaho, hereinafter referred to as the "Organization."

Section 2. Principal Office Location and Mailing Address. The place in Idaho where the principal office of the Organization shall be located is at 1169 E. Victory Rd., Boise, ID 83706. This address shall also be the mailing address of JIN.

The registered agent is Eric Taylor at 1169 E Victory Rd

Boise, ID 83706.

**ARTICLE II
PURPOSES AND LIMITATIONS**

Section 1. Purpose. JIN operates primarily to end sex trafficking, give financial and medical support to the underprivileged, and promote social equality for all in India. JIN shall only conduct activities that fulfill an exempt purpose as defined by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 2. Limitations.

2.1 JIN shall have no capital stock, and no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable reimbursement to individuals for costs in furtherance of exempt purposes as recognized by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

2.2 JIN may never engage in any political campaign activities on behalf of or in opposition to candidates for public office. Political campaign activities are those that influence or attempt to influence the selection, nomination, election or appointment of an individual to a federal, state, or local public office.

2.3 JIN reserves the right engage in a limited amount of lobbying activities (i.e., attempting to influence legislation) pursuant to their election made on Internal Revenue Code Form 5768 and subject to the limitations set forth in Section 501(h) of the Internal Revenue Code, and other corresponding laws. Any and all lobbying shall be related to JIN's exempt purposes. Lobbying activities shall occur in the event the Organization or its members contact, or urge the public to contact, members or employees of a legislative body for purposes of proposing, supporting or opposing legislation, or if the Organization advocates the adoption or rejection of legislation.

2.4 Notwithstanding any other provisions of these Articles of Incorporation, JIN shall not conduct or carry on activities not permitted to be conducted by an organization exempt under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE III FOUNDATIONAL BOARD OF DIRECTORS AND INCORPORATORS

ARTICLE IV DISSOLUTION

Upon the dissolution of the Organization, any funds remaining after paying or making provision for the payment of all liabilities of the Corporation, shall be distributed to one or more regularly organized and qualified nonprofit organizations as shall at that time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended from time to time, in such manner as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located,

exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V CONSTRUCTION AND SEVERABILITY

If there is any conflict between the provisions of these Bylaws and the Articles of Incorporation of this Organization, the provisions of the Articles of Incorporation shall govern.

Should any of the provisions or portions of these Bylaws be held unenforceable or invalid for any reason, the remaining provisions and portions of these Bylaws shall be unaffected by such holding and construed so as to as closely as possible effect the purposes of this Organization.

References to the Articles of Incorporation are to the articles on file with the Secretary of the State of Idaho, and amendments thereto. References to the Internal Revenue Code shall be to the Internal Revenue Code of 2014, as amended from time to time, or to corresponding provisions of any future federal tax code.

DECLARATION

These Articles of Incorporation were approved by unanimous 5-0 vote at a meeting of the Board of Directors of the Justice for India Network, Inc. on the 7th day of February, 2014 in Boise, Idaho.
