ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF CASCADE RENTAL EQUIPMENT CORPORATION

BE IT KNOWN, That we, the undersigned, President and Secretary respectively of Cascade Rental Equipment Corporation, do hereby certify in accordance with the provisions of Section 30-146, I.C., as follows, to-wit:

I

That a special meeting of the shareholders of all the issued and outstanding stock of the Cascade Rental Equipment Corporation was held at the offices of said company at Boise, Idaho, on the 30th day of January, 1958, pursuant to notice given as provided by law, at which meeting all the issued outstanding stock of the company was represented in person or by proxy.

II

That at said meeting all the shareholders of said corporation voted in favor of changing the name of said corporation from Cascade Rental Equipment Corporation to Cascade Equipment Corporation and voted in favor of said resolution, unanimously adopting the following:

"BE IT RESOLVED By the stockholders of Cascade Rental Equipment Corporation in meeting assembled for the specific purpose that the name of the company be changed from Cascade Rental Equipment Corporation to Cascade Equipment Corporation; and,

"BE IT FURTHER RESOLVED That Article First of the articles of incorporation of said company heretofore filed with the Secretary of State of Idaho, and with the County Recorder of Ada County, Idaho, be amended to read as follows:

'ARTICLE FIRST

That the name of this corporation is Cascade Equipment Corporation.'

and,

"BE IT FURTHER RESOLVED That the Chairman and Secretary of this meeting be directed to cause a proper certificate of this amendment to the articles of incorporation of this company to be executed and filed in accordance with the statutes of the State of Idaho in such case made and provided."

That R. V. Hansberger and T. H. Eberle are President and Vice President, respectively, of Cascade Rental Equipment Corporation, and

are Chairman and Secretary respectively of the meeting of the shareholders; that the articles of incorporation were amended by changing the name of said company, as hereinabove set forth, at said meeting, and the company has caused this certificate of articles of amendment to be executed and verified by its President and Secretary, R. W. Halliday, and its corporate seal affixed as by law provided pursuant to the resolution hereinabove set forth.
