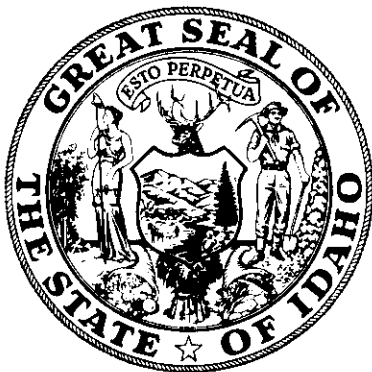

# ARTICLES OF INCORPORATION

## THE CHAPARRALS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following articles of incorporation for such corporation:

1. The name of the corporation shall be The Chaparrals, Inc.
2. The corporation shall be a non profit corporation as defined by the nonprofit corporation act.
3. The duration of the corporation shall be perpetual.
4. The purpose of the corporation shall be to provide a horse riding group for interested persons desiring pleasure riding, trail riding, improvement of horsemanship, and competition in horsemanship skills as well as any other purpose allowed under the Idaho Nonprofit Corporation Act.
5. There will be one class of membership which membership shall be controlled by the by-laws of the corporation as they may be adopted by the board of directors and members at large.
6. The registered agent for the corporation shall be Helen Reese, and her address is Rt 1 North Promise Lane, Pocatello, Idaho.


