ARTICLES OF INCORPORATION
OF

We, the undersigned natural persons of the age of eighteen (18) years or more, acting as incorporators of a corporation under the laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **F1 Environmental, Inc.**

SECOND: The period of duration is perpetual.

THIRD: The purposes for which the corporation is organized are:
