## ARTICLES OF INCORPORATION OF

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

#### ARTICLE I

The name of the corporation is <u>Johnny Jeb Bouis</u>. Inc. (hereafter "Corporation").
