## ARTICLES OF INCORPORATION IN TO THE OF THE

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1. Name. The name of the corporation is Orr Cattle Co.

ARTICLE 2. Shares. The corporation is authorized to issue 100,000 shares, all of one class.

- (i) The amount of a financial benefit received by a director to which he is not entitled,
  - (ii) An intentional infliction of harm on the corporation or the shareholders,
  - (iii) A violation of section 30-1-833, Idaho Code, or
  - (iv) An intentional violation of criminal law.

ARTICLE 7. <u>Indemnification of Directors</u>. The corporation shall indemnify each and every director of the corporation for liability, as defined in section 30-1-850(5), Idaho Code, to any person for any action taken, or any failure to take any action, as a director, except liability for:

- (i) Receipt of a financial benefit to which he is not entitled,
- (ii) An intentional infliction of harm on the corporation or its shareholders,
- (iii) A violation of section 30-1-833, Idaho Code, or
- (iv) An intentional violation of criminal law.
