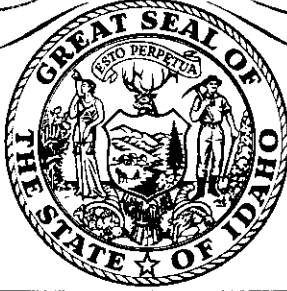

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

#### **COMMITTEE FOR GREATER IDAHO, INC.**

was filed in the office of the Secretary of State on the **Twenty-ninth** day of **May**, A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **123** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Boise** in the County of **Ada** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
OF  
COMMITTEE FOR GREATER IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

That We, the undersigned incorporators, being of legal age and all citizens of the United States and of the State of Idaho, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho, for the purposes hereinafter stated.

1.

That the name of the corporation is the Committee For Greater Idaho, Inc.

2.

The location of the said corporation shall be at 731 Warm Springs Avenue, Boise, Idaho, and the said corporation is to have perpetual existence.

3.

The corporation shall be a non-stock corporation and no dividends or pecuniary profits shall be declared or paid to the members thereof and certificates of membership only shall be issued. That the corporation shall be composed of members rather than stockholders. That the rights and interests of all members shall be equal. That the membership of this corporation shall consist of the incorporators and all other persons granted membership under the rules and by-laws of this corporation.

This corporation is organized not for profit and the purposes of this corporation are to provide a permanent and effective force to achieve the following:

1. Active support and whenever possible financial assistance to those organizations - Chambers of Commerce and others - which help to publicize Idaho; and thus to promote tourist trade and more government and private industry for Idaho.
2. A vigilant non-partisan guardianship with the financial means and specialized abilities to analyze and evaluate State budget needs, and legislation now in force, together with that which may be proposed in future legislative sessions; and to sponsor certain reform measures needed.
3. To encourage and give organized support from the home front to our Idaho Congressional Delegation in Washington D.C.
4. To keep a watchful eye on the operations of corporations, combines, power groups, and others, and when such operations, according to the findings of the Corporation, appear to be inimical to the best interests of the state, to bring corrective pressure to bear, through publicity and other means.
5. To sponsor the Idaho Centennial celebration in any manner outlined by the Board of Directors of the corporation.
6. To explore fully certain possibilities, wherein the year to year operation of the corporation might be maintained on a self-liquidating basis with continued financial assistance given to local Chambers of Commerce and other deserving agencies.
7. To give Idaho the composite leadership of those whose integrity and soundness of thinking, along with some dedication to the public interest, are recognized and respected in their various communities and accordingly qualified to make a definite

contribution in the building of a Greater Idaho.

8. To take any action deemed necessary by the corporation  
for the building of a Greater Idaho in any manner connected with  
the foregoing purposes.

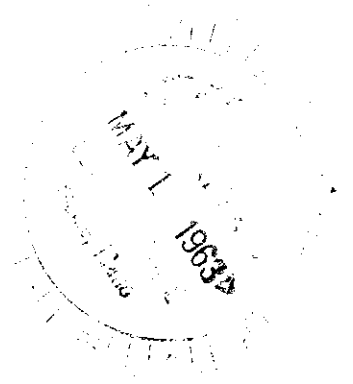
