KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, desiring to associate ourselves together and of forming a corporation under and by virtue of the laws of the State of Idaho, for the purposes hereinafter set forth and specified, do make, acknowledge, publish, declare and certify the following to be our articles of incorporation:

ARTICLE I.

The name of this corporation shall be the Shelley Banking Company, Limited.

ARTICLE II.

The objects and purposes for which this corporation is formed are to carry on and conduct a general banking business at Shelley, in Bingham County, Idaho; to receive and hold deposits of money, and to pay out the same; to make loans of money to individuals, associations, organizations, and corporations, private and public, and to take and receive, as security for any such loans, all such written instruments as pledges, mortgages, assignments, hypothecations, and transfers of real and personal property, choses in action, and any other things whatsoever of value; to receive and hold on deposit and in trust as security any estate in real or personal property, including the notes, bonds, or obligations or other instruments evidencing liability of states, individuals, associations, public or private corporations, and to purchase the same, to collect, hold, adjust and settle, sell and dispose of the same in any manner and for such prices and on such terms as may be agreed upon between the contracting parties; to purchase real or personal

That the term for which said corporation is to exist is fifty (50) years, from and after the date of its incorporation, unless sooner dissolved by the proper order of the court.

ARTICLE V.

That the capital stock of this corporation is Twenty Thousand (\$20,000.00) Dollars, divided into Two Hundred (200) hundred shares of the value of One Hundred (\$100.00) Dollars per share.

ARTICLE VI.
