Snyder, et al to Incorporate Town of Juliaetta, as entered in Book 1, Page 400 of Commissioners Journal - Latah County under date of Tuesday April 19, 1892. In Witness Whereof, I have set my hand and affixed my official seal at Moscow, Idaho, this 23rd day of June A. D. 1967.

et al In the matter of the petition of Chas Snyder/for the Incorporation of the Town of Juliaetta it was ordered that whereas the requirements of the law having been fulfilled that the prayer of Petitioners be and is hereby granted and the Boundaries of said Town designated as follows towit. Beginning at a point where the South line of Section 9 Tp: 37 North range 3 W. B. M. intersects the Big Potlatch River thence running in and Northeasterly direction along the County Line to where said County Line intersects the Middle Line of Section 34 Tp 38 North Range 3 W. B. M. thence North to Center of Section, thence West one Mile, thence South One half Mile thence West one half Mile, thence South one half mile, thence East one half mile thence South one half mile, thence East one fourth Mile thence South one mile thence East to place of beginning.

Chas. Snyder Jr. Rupert Schupfer H. Nichols T. R. Carithers and F. P. Zeigler were appointed Trustees of said Town of Juliaetta according to the prayer of Petitioners.

The above was taken from the April Term 1892 which began on Monday April 11th, 1892. The following opening paragraph appears: Page 383

"The Board of County Commissioners in and for Latah County Idaho. met at the Court House in Moscow in regular session on the second Monday in April 1892 according law. Present
