KNOW ALL MEN BY THESE PRESENTS: That we, ROD POYNOR, ROBERT NIELAND, REUBEN KAUTZ, NORMAN HACK and JOHN PENNINGTON, each of whom is a citizen of the United States of America, over the age of twenty-one years and a resident of the State of Idaho, desiring to form a corporation under and by virtue of the laws of the State of Idaho, do hereby associate ourselves together for said purpose and execute, acknowledge, adopt and file the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be WEISER LIONS ENDOWMENT FUND, INC.

ARTICLE II.

The names and addresses of the persons so associating themselves together for the purposes aforesaid are: Rod Poynor, Robert Nieland, Reuben Kautz, Norman Hack and John Pennington, all of whom reside and have their Post Office address at Weiser, Idaho;

ARTICLE III.

That the general nature of the business to be transacted by this corporation and the objects and purposes for which this corporation are formed are as follows:

To operate as a brother organization to the Weiser Lions Club, an association; to receive moneys from said Weiser Lions Club, and to engage in activities and programs for the purpose of obtaining further moneys to be used solely by said Weiser Lions Endowment Fund, Inc., for the purpose of furthering the conservation of sight and for the further purpose of making expenditures as from time to time in the discretion of the Board of Directors of said corporation for civic improvements for the benefit of the citizens of the City of Weiser, Idaho;

ARTICLE IV.

The principal place of business and registered office of this corporation shall be Weiser, Idaho;

ARTICLE V.

This corporation shall have no capital stock but shall recognize as members of this corporation all such persons who hold an official membership card in good standing from the International Association of the Lions Club and particularly the Weiser Lions Club;

ARTICLE VI.

That the government and management of the business affairs of this corporation shall be vested in a Board of thirteen (13) Directors and that

ARTICLE VII.

The Directors, as well as the members, shall have power to make prudential ByLaws as they may deem proper for the management of this corporation, not inconsistent with the general By-Laws of the corporation and power is hereby conferred
upon the Board of Directors by a <u>two-thirds</u> vote of said Directors to repeal
and/or amend the general By-Laws of the corporation and to adopt new general
By-Laws;

ARTICLE VIII.
