

Articles of Incorporation of the Idaho and
Oregon Irrigation Company Limited.

Know all men by these presents, That the
undersigned for the purpose of forming and
organizing a Corporation under the general
laws of the State of Idaho, have agreed
upon the following Articles of Incorporation

The name of this Corporation shall be
"Idaho and Oregon Irrigation Company Limited"

The purpose for which it is formed are
buying and selling arid or desert
lands: irrigating arid or desert
lands, and to that end owning construct-
ing maintaining and operating Dams.
Ditches. Canals. Reservoirs and any
and all other things incidental or
necessary to effectuate and carry
out the general purpose of
irrigation of arid lands buying
selling or leasing water rights, privileges
or contracts on real estate: executing
and selling irrigating or water contracts
or privileges: issuing and selling
land scrip or contracts: improving
permanently or otherwise, arid or
desert lands: buying or selling stock
in Companies or Corporations, owning
or controlling real estate, or construct-
ion or irrigation Companies; and
doing of any and all lawful acts

1 necessary or incidental to the carry-
 2 ing out of the general plan of irrigating
 3 improving and selling arid or
 4 desert lands and real estate generally.
 5 Also for establishing owning and
 6 controlling electrical plants for the
 7 purpose of furnishing light and
 8 power and as incidental thereto.

 10 contracts or agreements for furnishing
 11 or selling electrical light or power
