ARTICLES OF INCORPORATION OF TELEVISION SATELLITE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is TELEVISION SATELLITE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the carrying on of the business of sale, distribution, installation and maintenance of satellite television antennas, receivers and all related electronic and mechanical devices for the collection, amplification and transmittal of radio and television signals for both domestic and commerical application and purposes, and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 600 shares , with a par value of \$10.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.
