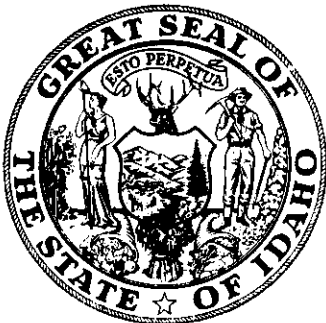

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
SUN VALLEY SKI & SPORTS TOURS, INC.**

Pursuant to the Idaho Business Corporation Act, all the shareholders and all the directors of Sun Valley Ski & Sports Tours, Inc., hereby adopt the following Articles of Amendment of its Articles of Incorporation.

1. **NAME OF THE CORPORATION.** The name of the corporation prior to the amendments called for herein was Sun Valley Ski & Sports Tours, Inc. The new name of the corporation is, and shall hereafter be, New Horizons, Inc.

2. **ADOPTION OF AMENDMENT.** Paragraph Number 1 of the Articles of Incorporation is amended to change the name of the corporation from Sun Valley Ski & Sports Tours, Inc., to New Horizons, Inc.

3. **DATE OF ADOPTION OF AMENDMENT.** The date of the adoption of the Articles of Amendment by the shareholders and directors of the corporation is April 3, 1995.

4. **NUMBER OF SHARES OUTSTANDING.** There is only one class of shares in the corporation. The number of shares outstanding in that single class is 7250 shares and all of those shares are entitled to vote.

5. **NUMBER OF SHARES VOTING IN FAVOR.** All shares voted in favor of the amendment, and no shares vote in opposition to the amendment. No shares of any class are entitled to vote as a class.

6. **EXCHANGE, CANCELLATION OR RECLASSIFICATION OF SHARES.** The amendment does not provide for an exchange, reclassification or cancellation of issued stock.

7. **EFFECT ON STATED CAPITAL.** The amendment does not effect a change in the amount of stated capital of the corporation.

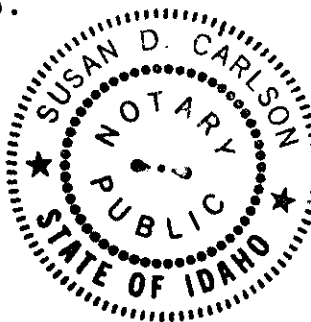
