ARTICLES OF INCORPORATION
OF
AUDIOLOGY LABORATORIES, INC.
a corporation

TO ALL TO WHOM THESE PRESENTS MAY COME:

We, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full legal age, do under and pursuant to the general corporation laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of AUDIOLOGY LABORATORIES, INC., a corporation.

ARTICLE I

The name of this corporation shall be:

AUDIOLOGY LABORATORIES, INC.

ARTICLE II

The purposes for which this corporation is formed are:

- a. To conduct hearing screening tests for the detection of hearing problems.
- b. To conduct threshold tests for determining the degree of hearing loss.
- c. To conduct tests to determine hearing evaluation.
- d. To manufacture, produce, use and sell mobile units equipped with apparatus and scientific devices to accomplish the tests for determining defects or hearing problems, the degree of hearing loss and hearing evaluations.

- e. To engage in the business of perfecting, patenting, manufacturing and selling various types of devices.
- f. To do any and all things necessary to carry out and accomplish the foregoing purposes.

ARTICLE III

The principal place of business of said corporation shall be Pocatello, Bannock County, Idaho, 344 N. 15th Avenue.

ARTICLE IV

The term of this corporation shall be perpetual.

ARTICLE V

The corporate power and business shall be exercised and controlled by a board of three directors.

ARTICLE VI

The amount of the capital stock shall be \$10,000.00 divided into 100 shares of common stock having a par value of \$100.00 per share.
