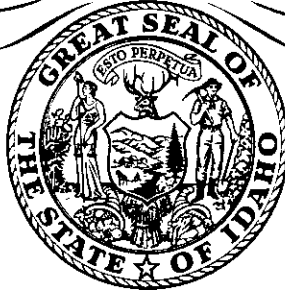

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

**COEUR D'ALENE LOG SCALING & GRADING BUREAU, INC.**

was filed in the office of the Secretary of State on the **Fifteenth** day  
of **July** A. D. One Thousand Nine Hundred **Sixty-Three** and  
is duly recorded on Film No. **125** of Record of Domestic Corporations, of the State  
of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and  
Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and  
successors are hereby constituted a corporation, by the name hereinbefore stated, for  
**perpetual existence** from the date hereof, with its registered office in this State located at  
**Coeur d'Alene** in the County of **Kootenai**  
and as such are subject to the rights, privileges and limitations granted to Non-Profit Coopera-  
tive Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
of  
COEUR D'ALENE LOG SCALING & GRADING BUREAU, INC.

We, the undersigned, being of legal age and citizens of and domiciled in the State of Idaho, under and pursuant to the provisions of Chapter 10, Title 30, Idaho Code, do hereby form a corporation, non-profit and cooperative, as authorized and permitted by statute under the following provisions:

ARTICLE I.

The name of the proposed corporation is  
COEUR D'ALENE LOG SCALING & GRADING BUREAU, INC.

ARTICLE II.

The purposes of this corporation are to establish, promulgate and maintain a uniform, accurate and scientific system for the grading, scaling and inspection of logs and other forest products, and to scale and inspect logs for itself, its members and others, and to charge and collect therefor a uniform schedule of fees for said services; and, in general, to do and perform any and all other acts that may be necessary or incidental fully to carry into effect the powers and franchises of this corporation.

ARTICLE III.

The corporation shall have perpetual existence.

ARTICLE IV.

The location and post office address of this corporation and the registered office of the corporation in the State of Idaho is  
114 S. Fourth Street, P. O. Box 982, Coeur d'Alene, Idaho.

#### ARTICLE V.

No capital stock shall be issued by said corporation and in lieu thereof membership cards shall be issued under and pursuant to the provisions of 30-1004 Idaho Code. Said membership certificates cannot be assigned so that the transferee can become a member of this corporation.

#### ARTICLE VI.

The bylaws of this corporation shall be adopted and fixed by the two-thirds vote of the directors or by a majority vote of a quorum of members present and said bylaws may be amended, altered or repealed, in whole or in part, and new bylaws adopted by a two-thirds vote of the directors or by a majority vote of a quorum of members of the corporation at any annual meeting or any special meeting of the members called for such purpose as provided by said bylaws.

#### ARTICLE VII.

The directors of this corporation shall not be less than eleven nor more than fifteen, which number shall be established by vote of the members at the initial meeting of the corporation or at annual meetings thereafter.

#### ARTICLE VIII.

Members of this corporation shall be of one class and all members shall have and retain one vote only and the rights and interest of all members shall be equal. The bylaws of the corporation will establish further rules governing membership.

WHEREFORE, the petitioners do pray that they be determined and adjudged to be a body corporate under the laws of

the State of Idaho as set forth in said Articles of Incorporation and that they thereby do have all rights and privileges thereunto pertaining.
