## CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE MERIDIAN STATE BANK

We, J. W. Cunningham and J. R. Cornell, Vice President and Secretary respectively of The Meridian State Bank, a Corporation organized and existing under the laws of the State of Idaho, do hereby certify that a Special Meeting of the shareholders of the said The Meridian State Bank, was held on the 6th day of April, 1938, at the hour of 3:00 o'clock P. M., at the office of the Corporation in the First National Bank Building at Boise, Idaho; said meeting being regularly held with the written consent of all the shareholders of said Corporation; That said meeting was called for the purpose of considering and voting upon a resolution to amend Article IV of the Articles of Incorporation to provide that the term for which said Corporation shall exist shall be extended for the period of twenty (20) years from and after the 13th day of April, 1938.

That at said meeting held on the 6th day of April, 1938, there were present shareholders in person or represented by proxy, representing the aggregate of 245 shares. The shareholders absent represented 5 shares.

That at said meeting the following resolution was presented and upon motion duly made and seconded, it was unanimously adopted:

BE IT RESOLVED by the shareholders of The Meridian State Bank that Article IV of the Articles of Incorporation be ameded to read as follows:

## ARTICLE IV

"That the term for which this corporation shall exist shall be extended for the period of twenty (20) years from and after the 13th day of April, 1938."

BE IT FURTHER RESOLVED, that the President or Vice President and Secretary of this Corporation be and they are hereby directed to execute, acknowledge and file as provided by law, a certificate amending the Articles of Incorporation of said Company as provided by the foregoing resolution and to do the things necessary in connection therewith as required by law."

That a vote was taken upon the adoption of said resolution and that upon such vote, 245 shares voted in favor of the adoption of the resolution and no votes were cast against the adoption of the same, and all the shares of said Corporation issued and outstanding were represented at said meeting, excepting 5 shares and that more than two-thirds of all of the voting shares of the Corporation voted in favor of said resolution, the resolution was declared adopted;

That thereupon, the President or Vice President and Secretary are authorized to prepare Certificate of Amendment to the Articles of Incorporation of The Meridian State Bank, setting forth the Amendment of said Article IV thereof, filing the same as provided by law.
