

ARTICLES OF INCORPORATION OF
" FARMER'S LATERAL COMPANY "

KNOW ALL MEN BY THESE PRESENTS , That we, the undersigned do hereby associate ourselves together for the purpose of and to sign, acknowledge , and adopt the following Articles of Incorporation, to-wit:

ARTICLE I.

That the name of this Corporation shall be "Farmer's Lateral Company".

ARTICLE II.

The term of the existence of this corporation shall be for fifty (50) years.

ARTICLE III.

That the principal place of business of this Corporation shall be Midvale, Washington County, Idaho.

ARTICLE IV.

That the purposes for which this corporation is organized are as follows: To build, purchase, lease, loan and acquire, and operate and maintain irrigation ditches, canals, water and water rights for the purpose for the purpose of furnishing irrigation and domestic water to the lands of the stockholders of this corporation , to build construct, own and operate pipe lines and other conduits for the purpose of furnishing irrigation and domestic water to the stock holders of this corporation, and generally to do and perform all things and acts necessary and requisite to carry into effect all of the objects for which this corporation is organized , including the right to own stock in another corporation.

ARTICLE V.

That the business and affairs of this corporation shall be

managed by a board of three directors and that until the first annual meeting of the stockholders Ch Meyers and I H Preston and James Goodnight shall constitute the first Board of Directors of said Corporation , who shall hold their offices until their successors are elected and qualified.

ARTICLE VI.

That the authorized capital of this stock shall be Five Thousand (\$5000.00) Dollars, divided into five thousand (5000) shares of the par value of One_(\$1.00) each.

ARTICLE VII.

That of the capital stock of this corporation, the following number of shares have been subscribed for by the following named persons, to-wit:
