**ARTICLE I
CORPORATE NAME**

The name of this corporation shall be :

**ARTICLE II
EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE III
PURPOSES**

**ARTICLE IV
CAPITALIZATION**

Each share of stock shall be entitled to one vote in all matters wherein the shareholders of the corporation shall be entitled to vote, and each share shall, in all respects, be equal to every other share.

The capital stock shall be transferred in accordance with such rules and regulations as may be established from time to time by the Board of Directors and set forth in the bylaws of the

1. For any breach of the director's or officer's duty of loyalty to the corporation or its stockholders;


2. For any acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of the law;
