

1. The name of the corporation is The Free Christian Church, dnc.

2. Section 1. Nonprofit Character.

This corp. is not formed for pecuniary profit, and no part of the net earnings of the corp. shall inure to the benefit of any Trustee of the Corp., any officer of the Corp., or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corp. affecting one or more of its purposes), and no Trustee or officer of the Corp. and no private individual shall be entitled to share in the dissolution of the Corp.

Section 2 Nonpolitical

No substantial part of the activities of the Corp. shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corp. shall not participate or intervene in any political campaign & including the publishing or distribution of statements on behalf of any candidate for public office.

Section 3 Tax-exempt Status

Notwithstanding any other provision of these Articles of incorporation, the corp. shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization

exempt from ~~tax~~ taxation under section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

- 3 The period of duration is perpetual.
- 4 The purposes of this corp is
  1. to promote the worship of God
  2. encourage and promote Christian ed. and conduct a parochial school.
  3. Ordain Deacons, Elders, Missionaries and Teachers
  4. all those things necessary to ~~fulfill~~ fulfill Christ's Commission to the church.
- 5 This Corp. shall have two classes of members
  - 1 Voting members must be male, 18 yrs old or older and either attend  $\frac{1}{4}$  of the services for a period of ~~not~~ three months, ~~or~~ or have a leave of absence from the board of directors. Voting members have the right to attend this church, worship God and receive such education or help as may be provided for them, by the board of directors
  - 2 Non Voting members are all others who attend this church including women and children non voting members have right to attend this church, worship God, and receive such education or help as maybe provided for them by

the board of directors.

- 6 Management of Corp. business shall be handled by a board three directors elected by the voting members.
- 7 The Voting members shall draw up a set of by-laws which the board of directors shall follow. Directors shall be elected biennially
