CHANGING THE NAME OF THE CORPORATION TO

ROBERTSON TRAILER SUPPLY, INC.

KNOW ALL MEN BY THESE PRESENTS: That the shareholders of Mobile Homes Suppliers, Inc., an Idaho corporation, have by legal and proper resolution of Amendments, adopted at a legally called and held meeting of the shareholders on December 20, 1966, pursuant to notice of such meeting given in strict conformity with the laws of the State of Idaho and the By-Laws of the corporation, amended the articles of Incorporation by striking out Article I of the original Articles of Incorporation, and substituting instead and in place thereof the following as Article I:

"ARTICLE I.

The name of this corporation is and shall be ROBERTSON TRAILER SUPPLY, INC. "
