ARTICLES OF INCORPORATION

OF

We, the undersigned, desiring to form a nonprofit corporation organized under the Idaho Non Profit Corporation Act do for the purpose and objects hereinafter stated, hereby associate ourselves with the intention of forming such corporation, and do hereby agree and declare as follows, to-wit:

I.

The name of this corporation shall be American Agriculture Movement of Idaho, Inc. The address of said corporation will be 549 S. 800 East, Jerome, Idaho 83338.

II.

The registered agent for said corporation shall be John Spanbauer, Jr., whose address is 549 S. 800 East, Jerome, Idaho 83338.

III.

IV.

The period of duration of this corporation shall be perpetual.

This corporation is a nonprofit mutual benefit corporation organized under the Idaho Nonprofit Corporation Act. the purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.

The specific purpose of this corporation is to:

- (1) To accomplish in accordance with the By-laws of this corporation the objective of seeking and maintaining 100% parity prices at the market place for all agricultural commodities.
- (2) To provide farmers of this state with representation in regard to legislation, both National and State.
- (3) To disseminate information pertaining to all phases of agriculture, including, but not limited to, production, storage and marketing.
- (4) To provide the agricultural community with an organization for meeting and discussing any and all topics pertaining to agriculture which may be of benefit to the membership of the farming community.

VI.

The objectives of this corporation shall be:

(1) To unite those persons engaged in the actual conduct of agricultural production for the promotion of their general welfare.

- (2) To provide actual leadership in the dissemination of information relating to the promotion of a better life and standard of living for those persons engaged in agriculture.
- (3) To provide the principles of good government and good citizenship.
- (4) To take and active part in the improvement of the civic, social and moral welfare of the nation.
- (5) To develope and promote leadership ability among those persons engaged in the agricultural profession.

VII.

This corporation shall have no capital stock and shall not engage in business for profit, but shall be supported by gifts, bequests, benefits, contributions, and fees and dues paid by members. Membership in the corporation shall be governed and controlled as provided in the Constitution and By-laws of this corporation.

VIII.

The officers by whom, and the manner in which the objects and purposes of this corporation shall be carried out, shall be a provided by the Constitution and By-laws of this corporation.

IX.

Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise

any powers that are not in furtherance of the specific purposes of this corporation.
