Re Use of "bane" in company name

Deer Ms. Mareski:

This is in response to your correspondence of October 12, 1999, asking whether Banc of America Auto Finance Corp. may use the word "bane" in its name in Idaho. According to your letter, the company is a Delaware corporation engaged in the business of vehicle lessing and financing.

Although we are taking no action to either approve or disapprove of the use of the name Banc of America Auto Finance Corp., you should be aware that there is a regulatory implication.

Idaho Code§26-1202 makes it a felony for any person, other than a national bank, not authorized to operate as a bank under the Idaho Benk Act, to advertise or use as part of its corporate name the word "bank" or "banker" or any other word of similar import. While the Department of Finance does not have the authority to prosecute under this statute, another agency could conceivably do so. The Department is therefore not in a position to specifically approve such use.

It is our belief that the use of the term "bane" under the circumstances you have described is not misleading to the general public. We are therefore recommending to the Director that the Department take a "no action" position on your use of the word "bane".
