(b) 216 votes were cast in favor of dissolution.





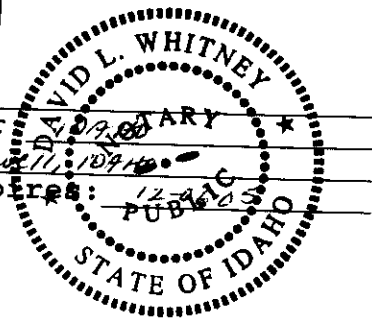
