ARTICLES OF INCORPORATION

- 1. The name of this corporation is The Boise Basin hailroad Company.
- 2. The purpose for which this corporation is organized is to construct, own, maintain and operate a railroad line with such branch lines and extensions as may from time to time be deemed desirable and as may be authorized by law.

The said railroad line is to begin at or near the junction of Moore's Greek and Boise River, near the common corper of the Counties of Ada, Elmore and Boise, in said State of Idaho and extend thence in a generally Northerly direction, following mainly the course of said Moore's Greek to a point at or near the junction of Moore's Greek and Grimes' Greek in said Boise Jounty, a distance of twenty miles, more or less.

The total estimated length of said railroad line is twenty miles and the same will be situated within the Counties of Ada, Elmore and Boise in said State of Idaho.

- 3. The place where its principal business is to be transacted shall be Boise, Ada County, State of Idaho.
- 4. The term for which it is to exist is fifty years from and after the date of its incorporation.
- 5.
