KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, President and Secretary, respectively, of SNAKE RIVER EQUIPMENT COMPANY, an Idaho corporation, do hereby certify in accordance with the provisions of Section 30-148, Idaho Code, as follows:

I.

At a special meeting of the shareholders held on the 13th day of June, 1975, pursuant to waiver of notice signed by all shareholders, at which meeting in excess of two-thirds (2/3rds) of the issued and outstanding stock of the company was represented in person or by proxy, it was unanimously determined to change and amend the Articles of Incorporation of this company and in relation thereto the following resolution was unanimously adopted at said stock-holders' meeting:

"RESOLVED: That Article II of the Articles of Incorporation of said company heretofore filed with the Secretary of State and with the County Recorder, Bonneville County, State of Idaho, be amended to add thereto an additional section to read as follows:

10. To engage in the business of handling, administering negotiating, selling and otherwise dealing in and with applications for credit life and disability insurance and all other forms of insurance available in the general market, but not to act as an insurer or to be engaged in the business of insuring, and to assist customers in applying for and obtaining credit life and other insurance generally in conjunction with the purchase of equipment, motor vehicles, and other merchandise.

FURTHER RESOLVED: The President and Secretary of this corporation, who were in attendance at this meeting, are hereby authorized and

directed to cause a proper certificate of this amendment to the Articles of Incorporation of this company to be executed and filed in accordance with the statutes of the State of Idaho in such cases made and provided."

George Watkins, Sr. and George Watkins, Jr., who are the President and Secretary, respectively, of Snake River Equipment Company, and who were the Chairman and Secretary, respectively, of the special meeting of the shareholders hereinbefore mentioned, and said company have caused this certificate of Articles of Amendment to be executed by its President and Secretary, and its corporate seal to be affixed, as by law provided, and pursuant to resolutions hereinbefore set forth.
