ARTICLES OF INCORPORATION
OF
CJ CATERING, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation shall be CJ CATERING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized for the purpose of providing food, beverage and catering services and further for the purpose of engaging in all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock with no par value.

FIFTH: The transfer of the shares of the corporation is restricted and such restriction is specified in the bylaws of the corporation.

SIXTH: The address of the initial registered office of the corporation is 1819 Crestview Avenue, Nampa, Idaho, 83686 and the name of its initial registered agent at such address is Clyde Hill.



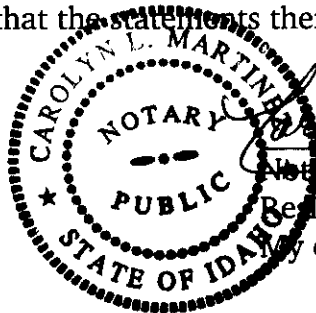

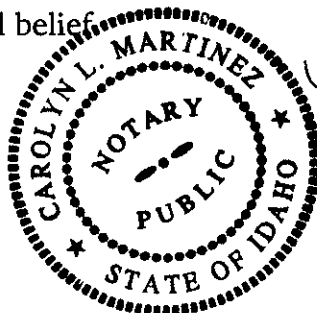
