ARTICLES OF INCORPORATION

Know all men by these presents: That we, citizens of the United States and residents of the State of Idaho, this day have voluntary associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I

The name of this corporation shall be Rossi Investors Inc..

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized, is to include the transaction of any or all lawful business for which corporations may be incorporated under this act.

ARTICLE IV
