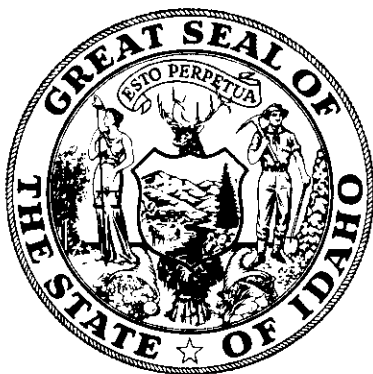

ARTICLES OF INCORPORATION  
OF  
REGION IV CHAPTER OF ~~THE~~  
IDAHO OUTFITTERS AND GUIDES ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are natural persons of full age and citizens of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, pursuant to the provisions relating to nonprofit corporations in the State of Idaho, being Sections 30-301 to 30-332, Idaho Code, and the acts amendatory thereof and supplemental thereto, do hereby certify as follows, to-wit:

I

That the name of this corporation is the "REGION IV CHAPTER OF THE IDAHO OUTFITTERS AND GUIDES ASSOCIATION, INC.".

II

That this corporation is not formed for pecuniary profit.

III

That the period of existence of the corporation is perpetual from and after the date of its complete incorporation.

IV

That the purposes and objects for which this corporation is formed are as follows:

1. The primary purpose of this corporation is to promote travel and conventions within Region IV of the State of Idaho, including the counties of Blaine, Camas, Cassia, Gooding, Jerome, Lincoln, Minidoka and Twin Falls.

2. To promote generally and specially the interests of its members engaged in tourist recreation, fishing and hunting pursuits.

3. To foster a spirit of goodwill among those persons engaged in the outfitting, guiding and recreational industry, to promote ethical practices in their relationship with each other and the general public, to the end that all interests may be served fairly.

4. To promote and advertise recreational and wildlife features of the State of Idaho.

5. To assist, co-operate and enter into agreements with the proper departments of the United States Government and the State of Idaho, in the promotion, caring for, preservation, conservation, development, harvesting and taking of fish, game and wildlife.

6. To further the adoption of adequate rules and regulations for the preservation and taking of wildlife within the State of Idaho.

7. To collaborate, co-operate and exchange data with similar organizations.

8. To own and control real and personal property and to sell, assign and lease the same.

9. To borrow, give or lend money, pledge, mortgage, or hypothecate property or security for the payment of any debt or obligation and to do so at any and all times necessary to carry out the general purposes.

10. To pursue any and all other lawful purposes of a nonprofit corporation without being restricted or limited to the above enumerated purposes and to do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, or the attainment of any of the objectives or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other associations, firms, individuals or governmental agencies, and do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers, or any part or parts thereof, provided the same is not inconsistent with the laws of the State of Idaho.

V

The address of the initial registered office is 211 Dollar Drive, Ketchum, Idaho 83340 and the name of its initial registered agent at such address is Phil Crabtree.

VI

That, inasmuch as this corporation is a nonprofit association, there shall be no capital stock. The revenues of

the corporation shall be from grants and contributions, and upon dissolution, no residual asset shall inure to any individual, but shall be devoted to similar purposes to those of this corporation.

#### VII

The corporation shall have no members. The board of directors of the corporation shall be elected by the Idaho Outfitters and Guides Association, Inc., P. O. Box 95, Boise, Idaho 83701.

#### VIII

The number of directors constituting the original board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until their successors are elected and qualified are:
