ARTICLES OF INCORPORATION

OF

COEUR D' ALENE JAY-C-ETTES, INC.

KNOW ALL MEN, BY THESE PRESENTS, that we, the undersigned, all of whom are of legal age and citizens of the United States, have this day voluntarily associated ourselves and do hereby, and by these Articles of Incorporation, unite and associate ourselves for the purpose of forming a nonprofit corporation under and pursuant to the provisions of Chapter 11, Title 30, of the Idaho Code, and we hereby acknowledge, enter into, and adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be Coeur d' Alene Jay-C-Ettes, Inc.

ARTICLE II.

The period of the duration of this corporation shall be perpetual.

ARTICLE III.

The principal office in the State of Idaho of this corporation is at Coeur d' Alene, County of Kootenai, Post Office Box No. ______.

ARTICLE IV.

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

- 1. To advance the educational, civic, social, commercial and economic interests of the city of Coeur d' Alene, Kootenai County, Idaho, and the general welfare and prosperity of its tributary territory; to promote integrity and good faith, just and equitable principles in business and professional activity, and uniformity in commercial usages, and to acquire, preserve and distribute educational, civic, social, commercial and economic statistics and information of values; to discover and correct abuses; to prevent or adjust controversies; to have a part as representing the said city in the consideration and decision of public policy in municipal, county, state and national affairs.
- 2. To provide a suitable place for the meeting of its members, the establishment of facilities for educational, civic, social, commercial, economic and political research, including social and recreational features, so as to sustain interests of its members and secure intelligent action on the part of its boards and committees in the accomplishment of its general purpose.
- 3. To acquire, dispose of, or otherwise operate, maintain and control any and all types of property or interests therein, necessary for the business and objects of the corporation.

ARTICLE V.

This corporation is not organized for profit and it shall have no capital stock.

ARTICLE VI.

The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined and fixed by the By-laws.

ARTICLE VII.

The private property of the members shall not be subject to the payment of corporate debts, liabilities or obligations to any extent whatever.

ARTICLE VIII.

The Board of Directors of this corporation shall be not less than three (3) nor more than fifteen (15), who shall be elected by a majority vote of all members in good standing of said corporation, and they shall be elected annually and shall be designated and consist of a President, First Vicepresident, Second Vice-president, Secretary, Treasurer, State Director, State Reporter and Director, and such other officers as may be provided by the By-laws.
