I, the undersigned incorporator for the purposes of forming a corporation under and pursuant to Title 30, Chapter 1 of the Idaho Code, do hereby certify the following:

The name of the Corporation shall be:

PORTEL. CO.

II.

The duration of this corporation shall be perpetual.

III.

The purpose of this Corporation is to engage in any lawful act of activity for which a corporation may be organized under the General Corporation Law of Idaho.

IV.

The location of the registered office of this corporation in the State of Idaho shall be: 302 Elder Building, Coeur d'Alene, Idaho 83814 and the resident agent at that address is Richard W. Kochansky.

V.

The aggregate number of shares which this Corporation shall have the authority to issue is 1000 shares, with a par value of \$100.00 per share, having an aggregate par value of \$100,000 which shall be known as common stock. This stock, to the extent possible, shall be issued pursuant to the provisions of Sec. 1244 of the Internal Revenue Code.

The officers of this Corporation shall consist of a President, Vice-President, Secretary, and Treasurer, and any two of the offices except those of President and Secretary, may be held be the same person, unless provided otherwise by law.
