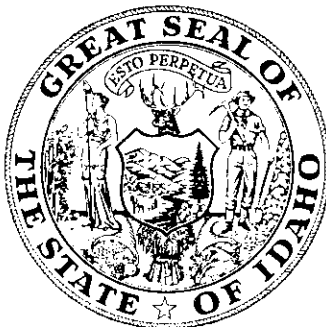

ARTICLES OF MERGER

OF

THE CALVARY BAPTIST CHURCH OF SANDPOINT, IDAHO, INC.,
INTO FIRST BAPTIST CHURCH OF SANDPOINT, IDAHO,
AN IDAHO CORPORATION

ARTICLE I.

The plan of merger is for Calvary Baptist Church of Sandpoint, Idaho, Inc., to be merged into First Baptist Church of Sandpoint, Idaho, an Idaho Corporation, which shall be the surviving corporation. The terms and conditions of the merger are set forth in the Draft Constitution for the Merger of First Baptist Church and Calvary Baptist Church.

ARTICLE II.

The number of members entitled to vote for each corporation was the following:

- A. Calvary Baptist Church of Sandpoint, Idaho, Inc.: Thirty-two (32); and,
- B. First Baptist Church of Sandpoint, Idaho, an Idaho Corporation: Twenty-eight (28).

ARTICLE III.
