We, the undersigned, natural persons of the age of R& gears to more, acting a incorporators of a corporation under the laws of the States of daho adopt the following articles of incorporation for such corporation:

First: The name of the corporation is JMG Inc.
Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are:

a.
