## Articles of Incorporation

We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a corporation under the laws of the State of Idaho adopt the following articles of incorporation for such corporation:

First: The name of the corporation is JMG Inc.

Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are:

a. To manufacture, produce, purchase, or otherwise acquire, sell or otherwise dispose of, import, export, distribute, deal in and with, whether as principal or agent, goods, wares, merchandise, and materials of every kind and description, whether now known or here after to be discovered or invented.

b. To engage primarily in the specific business of selling, buying, manufacturing, marketing, and distributing real and personal property of every kind and description.

c. To engage generally in the business of retail and wholesale selling, advertising, and marketing of services of every kind and description.

d. To engage in any business, related or unrelated to those described in clauses a,b, and c of this Article, from time to time authorized or approved by the board of directors of this corporation or carry on any other trade or business which can, in the opinion of the board of directors of the company be advantageously carried on in connection with or auxiliary to those described in clauses a,b, and c of this Article, and to do all such things as are incidental or conducive to the attainment of the above objects or any of them and all other acts authorized by law.

Fourth: The aggregate number of shares which the corporation shall have authority to issue is 10,000. All stock under such authority shall be classified as common stock. All such shares shall be without par value.

Fifth: The corporation will not commence business until at least 3000 dollars have been received by it as consideration for the issuance of shares.

Sixth: Cumulative voting of shares of stock is authorized.

Seventh: There shall be no provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation.

Eighth: No provisions for the internal affairs of the corporation shall be set forth.

Ninth: The Address of the initial registered office of the corporation is 692 East Anderson, Idaho Falls, Idaho 83401, and the name of its initial agent at such address is J. Mark Hanny.

Tenth: Address of the principal place of business is 692 East Anderson, Idaho Falls, Idaho 83401.



