The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

## ARTICLE I

The name of the corporation is \_\_\_\_\_\_SALMON BUS LINES, INC. (hereafter "Corporation").

### ARTICLE II
