AMENDED ARTICLES OF INCORPORATION  
OF  
TRAILS WEST OF IDAHO, INC.

Pursuant to a resolution of all shareholders of the corporation adopted unanimously on July 7, 1992, these Amended Articles of Incorporation are hereby stated and adopted. The sole amendment to the original Articles of Incorporation is with respect to the corporate purposes, set forth in Article III below.

ARTICLE I

The name of the corporation is Trails West of Idaho, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, and specifically including insurance sales and the operation of an insurance agency.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 5,000, \$1.00 par value.

ARTICLE V

There are no provisions denying preemptive rights.

ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are the By-Laws of the corporation.

ARTICLE VII

The address of the registered office of the corporation is 10617 West Hiawatha Drive, Boise, Idaho 83709 and the name of its registered agent at such address is Clark M. Walter.

ARTICLE VIII

The number of directors constituting the board of directors of the corporation was and remains two, and the names and addresses of the persons who are to serve as directors until the next annual meeting of shareholders or until their successors are elected and shall qualify are:

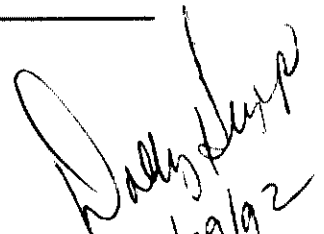
